

# DSF<sup>2</sup><sup>®</sup> Layout

## Important Notes:

- DSF<sup>2</sup> does not put your file in walk sequence order. You must still presort the list to sequence your records for postage discounts.
- Additional processing will be required to insert standardized or DSF<sup>2</sup> address information from the DSF<sup>2</sup> output into your mailing list.

Each output record contains four data areas:

- *Original Input Data* - Original information received for processing.
- *Standardized Input Data* - Address in a standardized format. Includes the newly applied ZIP + 4<sup>®</sup> code, standardized address, city, state and ZIP Code<sup>™</sup> information.
- *Delivery Point Data* - Indicates if the input address is a valid delivery point and identifies CMRAs.
- *DSF<sup>2</sup> Data* - Address characteristics and pseudo walk sequence numbers.
